Please Read This Notice Before Completing The Enrolment Form.

This confidential enrolment form asks for personal information about your child as well as family members and others that provide care for your child. The main purpose for collecting this information is so that Coburg Special Developmental School can register your child and allocate staff and resources to provide for their educational and support needs. All staff at Lockington Consolidated School and the Department of Education & Early Childhood Development are required by law to protect the information provided by this enrolment form.

Health information is collected so that staff at Coburg Special Developmental School can properly care for your child. This includes information about any medical condition or disability your child may have medication your child may rely on while at school, any known allergies and contact details of your child's doctor. Coburg Special Developmental School depends on you to provide all relevant health information because withholding some health information may put your child's health at risk.

Coburg Special Developmental School requires information about all parents, guardians or carers so that we can take account of family arrangements. Family Court Orders setting out any access restrictions and parenting plans should be made available to Coburg Special Developmental School. Please tell us as soon as possible about any changes to these arrangements. Please do not hesitate to contact the Principal at Coburg Special Developmental School, if you would like to discuss, in strict confidence, any matters relating to family arrangements.

EMERGENCY CONTACTS

These are people that Coburg Special Developmental School may need to contact in an emergency. Please ensure that the people named are aware that they have been nominated as emergency contacts and agree to their details being provided to Coburg Special Developmental School.

STUDENT BACKGROUND INFORMATION

This includes information about a person's country of birth, aboriginality, language spoken at home and parent occupation. This information is collected so that Coburg Special Developmental School receives appropriate resource allocations for their students. It is also used by the Department to plan for future educational needs in Victoria. Some information is sent to Commonwealth government agencies for monitoring, planning and resource allocation. All of this information is kept strictly confidential and the Department will not otherwise disclose the information to others without your consent or as required by law.

Information sent to the Department of Human Services is aggregate data so no individual is identified.
